The Representative's Corner

Like you, my wife and I recently received our Cuyahoga County property tax bill. Also, probably like you, ours went up a lot, much to our chagrin.

During my first term serving you in the Ohio House of Representatives, I served on the Ways and Means Committee, which is the committee tasked with reviewing proposed laws involving taxes. Know that I was very vocal about providing property tax relief before the recent increases went into effect. We knew this was coming and I was hopeful that we could do something at the Statehouse in advance to provide relief to Ohio's property owners and renters, whose rents are rising due to their landlord's property taxes rising.

Unfortunately, most of my colleagues disagreed and, instead, supported a state income tax cut, which primarily helped very high income individuals. I expressed how I hear daily about property tax concerns and literally never



about state income taxes. Unfortunately, House Bill (H.B.) 57 was the only property tax relief bill that passed. It adjust the Homestead Exemption for seniors to inflation, which is a step in the right direction, but not enough.

Below are the other the bills that I co-sponsored that would have provided real property tax relief. Unfortunately, none of them achieved enough support and died at the end of 2024. I am in talks now with my colleagues to reintroduce them in hopes for success this time.

H.B. 60 - The Homestead Exemption Expansion Act would raise the tax exemption of a property's value from \$25,000 to \$40,000, providing nearly \$250 million in targeted relief to an additional 75,000 seniors.

H.B. 187 - The Ohio Homeowners' Relief Act would modify the way counties calculate property values by weighing property values for the past three years rather than just one. This averaging would help protect homeowners from large tax increases as a result of the property valuation adjustments occurring in one year.

H.B. 263 - The 70/70 Plan would freeze property taxes for residents aged 70 and older whose incomes are less than \$70,000.

H.B. 645 – The Circuit Breaker Act would provide a rebate of up to \$1,000 to homeowners and renters whose property taxes or rent exceeds 5% of their income. This would provide nearly \$1 billion in relief for over 1.3 million middle-class homeowners and renters.

High property taxes are the result of both the choices that the Legislature has made and the ones it has failed to make. Ohioans vote on levies more often than any other state in the country, yet other states boast stronger property tax relief programs. In the last decade alone, Ohio lawmakers have eliminated the 12.5% rollback that used to lower all levies, allowed the homestead exemption to be eroded by

to expand local levy reliance. The most impactful proposals would cost less than 1% of the state's \$95 billion dollar budget. The state should fund additional,

means-tested property tax relief that is targeted to seniors and working people. It breaks my heart when a resident calls my office to tell me that they don't know how they are going to be able to stay in their home or apartment with all of the rising costs. I stand firmly committed to working with my Democratic and Republican colleagues at the Statehouse to provide property tax relief to all homeowners and renters in Ohio.

MD, join three others already serving patients at this location.

"At UH Parma Medical Center, we are committed to enhancing access to specialized care close to home," said James Hill, MD, Chief Operating Officer of UH Parma. "The expansion of the UH Eye Institute is a testament to our dedication to meeting the needs of our community by providing world-class eye care right here in Parma. This collaboration ensures patients can receive comprehensive care without the need to travel, improving convenience and outcomes for our westside neighbors."

Office expansion and the acquisi-

tion of new equipment has been made possible through the Parma Hospital Health Care Foundation and UH Eye Institute philanthropic support.

"Previously Parma area's eye care was almost exclusively served by independent ophthalmologists," said Douglas Rhee, MD, Director of the UH Eye Institute. "Patients had to go to UH Westlake Health Center or main campus for the majority of eye services. Now even surgery can be done at UH Parma."

The UH Eye Institute is also expanding its footprint at the UH Westlake Health Center. This location, off Clague and Detroit roads near I-90 in Westlake, is adding a provider in an expanded office space for greater access to the full range of clinical and operative services.

Services are growing as well in the UH East and South Markets, expanding coverage in retinal care and adding corneal procedures and oculoplastics. The Eye Institute is aiming to grow its surgical offerings at UH Lake West and double its space, with more clinical services, in the Western Reserve building in Hudson.

"We're the second smallest department in UH Medical Group, but we manage to provide a full range of eye care services throughout metropolitan Cleveland and beyond," Dr. Rhee said.



Hitting The Trails In An All-Terrain Wheelchair

"If a child is to keep alive his inborn sense of wonder, he needs the companionship of at least one adult who can share it, rediscovering with him the joy, excitement, and mystery of the world we live in." – Rachel Carson

Parma resident Zac Kraley is a very adventurous person who loves being outside. Zac also uses a wheelchair. "It's a team effort," said his mom, Chris Markulik. "Outdoor activities keep us inspired mentally and physically to keep growing, exercise, lead a happy life, and foster our sense of wonder." One thing that has helped them get out on the trail is the Cleveland Metroparks all-terrain (AT) wheelchair at Garfield Reservation. This AT wheelchair was funded by a grant from the Cuyahoga County Board of Developmental Disabilities (Cuyahoga DD). "The AT wheelchair funded by

Cuyahoga DD provided us with a foundation of support. It empowers me to take Zac. I knew it was meant for people within his community," Chris said.

Chris was originally interested in adapted hikes. She spoke with a Metroparks staffer during the Cuyahoga DD Family & Provider Resource Fair and took home a flyer. "Zac enjoys driving his wheelchair and the all-purpose trail near our home. I didn't know about the AT chair till after I went home and researched a bit more and signed up for pie iron cooking. Zac and I attended the outdoor cooking event and spoke with the Metroparks inclusion specialist," she said. "I told her my story of how we tried to reserve an AT chair at a Georgia State Park. I inquired [at Metroparks] about the AT wheelchair. I was excited for Zac for to have the opportunity," Chris said. It was a great experience for both Zac

and his mom. "Having the experience to have Zac use the AT wheelchair was fabulous. Just the smile on his face made my day. It was a wonderful learning opportunity for Zac. He was able to experience his body and mind in a new and different environment not just in a different chair, but a new park, terrain and trail and enjoy a winter activity in a different way," Chris said.

Zac made the most of the experience. "He was able to socialize with staff and be around people in the community. He even had the chance to work on communication, reading head and arm control, pointing and eye gazing," Chris said. Perhaps most importantly, "it opened a door to be outside, get some exercise and move, stop and pause, take in the sights of a beautiful, peaceful surrounding for new conversation and reflection, and take time to give thanks," Chris said.

Zac is also active with 3Trackers, an organization that encourages people with disabilities to participate in adaptive recreational sports, including water skiing, snow skiing, cycling, and kayaking.

There Is No Such Thing As A "Deep State"

One of the recurring themes of the Trump campaign last year was this thing about a "deep state" that was stifling American's freedom and was overly bureaucratic and "too WOKE." I am here to debunk that lie and tell the truth about our government's civil service.

On Saturday July 2, 1881, newly inaugurated President James A Garfield was at the railroad station in Washington DC to board a train to the shore for the July 4 weekend. Out of the crowd came a deranged disgruntled office seeker named Charles Guiteau. He was upset that he had not been given an audience for a federal office with the new administration. He fired two shots into Garfield from a pistol hidden in his coat.

President Garfield lingered for two and a half months before dying of sepsis caused by his wounds. A contributing factor in his death was the lack of sanitation and sterilization in that period. His presidency was only six and a half months. President Garfield is buried along with his wife in a tomb in Cleveland's Lakeview Cemetery.

He was succeeded by his Vice President Chester A Arthur who had been the Collector of the Port of New York, perhaps the busiest and richest port in the nation. This position was a patronage job that made Chester Arthur very wealthy and influential. He was a product of a corrupt New York political machine that controlled all government positions. At that time government jobs were given out to supporters based on a "spoils system" that went back to Andrew Jackson's saying "to the victor go the spoils" as they can appoint all government officials.

To say that this system was corrupt was an understatement. Many government officials were corrupt criminals who enriched themselves off the public. Shocked by the assassination of a President by a disgruntled office seeker; the congress enacted the Pendleton Civil Service Act in 1883. President Arthur signed it into law that year. This act became the basis of our career civil service.

Federal employees were permanent hires based on merit rather than political connections. They were prohibited from engaging in any political activity other than voting. They could not be fired when there was a change in the administration. This 1883 act has been strengthened and expanded to the federal civil service and has been copied by all states and cities in the Unted States for public employees.

I have a close family member who is a retired federal law enforcement official. In his position, he busted child pornographers and those who also trafficked in children for sex. He also investigated fraud on the Chicago Board of Trade. After the events on September 11, 2001, they began investigating money laundering by terrorist organizations and rogue nations as well as organized crime.

These people who work for our government are not part of a "deep state" conspiracy. They keep us safe from terrorists and prevent airplanes from crashing into each other. It is the federal air traffic controllers that make flying across the Unted States safer than driving a car across town. It is those dedicated people that make sure that social security payments are sent out and contributions are credited. They make sure that people pay their taxes. It was federal postal inspectors that were able to put Chicago gangster Al Capone in Alcatraz prison.

These career civil servants cannot be fired for political reasons and are prohibited from engaging in any political activity other than voting if they

are employed by the government. They also are pledged to be confidential and cannot reveal any sensitive personal information without a warrant.

It is these people that make sure that despite a change in administration government benefits continue to be paid and that the work of the government is not interrupted. Sure, the President can appoint the heads of government departments that are subject to senate confirmation as to their fitness for the position.

However, in the past five weeks Donald Trump has turned all that on its edge. He is on s spree of illegally firing career government employees and has an unelected unconfirmed and unvetted billionaire who has some lucrative contracts with the federal government rooting around in government offices

and agencies firing workers and slashing their budgets under a "Department of Government Efficiency" that has not been created by congress as the constitution allows.

This has been a campaign of "shock and awe" that has caught the nation by storm. But this also defies the constitution and the oath that the President took on January 20 to "protect and defend the constitution of the United States against all enemies foreign and domestic." Last week Donald Trump had his image on a fake magazine cover wearing a crown with the lettering "all hail the king." We fought a war that started 250 years ago this April to get rid of being ruled by a king. Our founding fathers must be rolling over many times in their graves.




Love Coffee







ADAMHS Board/ The Centers Partnership

A new Behavioral Health Crisis Receiving Center (CRC) planned for Cuyahoga County will soon help strengthen the region's crisis continuum of care. The ADAMHS Board, The Centers and Cuyahoga County are partnering to create a facility in Cleveland's Central neighborhood that will support countless individuals experiencing a mental and/or addiction emergency. Construction is expected to begin in spring 2025

A first-of-its kind in Cuyahoga County, the CRC will provide accessible, short-term behavioral health care for people experiencing a mental health crisis or substance use disorder. CRCs can help reduce the need for emergency department visits, jail bookings, and divert individuals from psychiatric hospitalizations by providing a community-based, home-like alternative environment.

When the CRC opens in fall 2026, The Centers will operate a comprehensive 24/7 facility that includes services such as urgent care, medication refills, de-escalation, triage, assessment, observation, treatment, coordination, linkage to services, and the management of both voluntary and involuntary clients, in addition to other services.

The CRC will develop a robust referral network to route patients on discharge to appropriate in-patient,

out-patient, or community services and will work with local hospital partners to assist them in training physicians in behavioral health crisis treatment.

As proposed, the behavioral health crisis receiving center will employ an estimated 200 caregivers and serve about 17,000 people.

Funding and Investment

The project is made possible through the ongoing collaboration of public and non-profit partners. In summer 2024, The Ohio Department of Mental Health & Addiction Services awarded a capital grant of \$6.8 million in American Rescue Plan Act funds to the ADAMHS Board. The Board —

responsible for the planning, funding and monitoring of mental health services in Cuyahoga County – saw the need for a crisis center and selected The Centers to help bring the project to fruition.

In addition to the initial capital award, the ADAMHS Board is committing \$2.5 million for startup costs. The ADAMHS Board will provide oversight of the capital project and operations of the CRC while continuing to fund the facility. Cuyahoga County is supportive of the project and is currently finalizing its financial commitment from both a capital and operational perspective.

Funding will be used to renovate the first two floors of an existing building at 2322 E. 22nd St., which will become the new CRC.
